Sub: Financial Assistance to Outstanding sports persons for International participation.

With a view to provide opportunity and encouragement to the outstanding sports persons of the State to expose their talent in the International tournament/competitions it is imperative to render financial support to such sports persons who on the basis of their sporting excellence are selected to represent the country in recognized International sports events.

Keeping this objective in view a scheme called "Financial Assistance to outstanding sports persons for International Participation is formulated which shall come into force with effect from the date of issue of this Resolution.

| Para - 2 | INTERNATIONAL EVENTS<br><br>International events means;<br><br>a) Olympic Games, World Cup, World Championship, Asian Games, Asian Championship, Commonwealth Games, Afro-Asian Games, SAF Games, World university/School Games/ ATP Ranking Grand Slams Tennis Tournaments/All England Badminton Championship (Association of Tennis Professionals), O.D.I. (Cricket) and Test Matches (Cricket) and other competitions/Tournaments with similar status.<br><br>b) Test Matches between two countries in Games like Volleyball, Hockey etc.<br><br>c) Invitation Tournaments/Championships organized under the aegis of the concerned International Federations. This will hold good to all categories of age group ie. Seniors, Juniors and Sub-Jrs. |

| <p>Para – 3</p> | <p>REPRESENTATIONS</p> <p>Representation means;</p> <p>a) The team/individual after participating in the National level Tournament conducted by the concerned Federation and after duly selected by a genuine selection committee should represent the country in one of the above mentioned International Tournaments/competitions.</p>   |
| <p>Para – 4</p> | <p>ELIGIBILITY</p> <ol style="list-style-type: none"> <li>(1) He/She must be a permanent resident of the State of Orissa</li> <li>(2) He/She should have participated in the lower level competition (District level) organized by the recognized District/State level Associations.</li> <li>(3) He/She should have achieved outstanding result in the State level competition. For such State level competition, the concerned State Association should have ensured participation of maximum affiliated Units (District)</li> <li>(4) While selecting the sports persons to represent the State in National level competition, conducted by concerned National Federation, the duly constituted selection committee should select the person impartially exclusively on the basis of the performance/achievement.</li> <li>(5) Sports persons participating in approved disciplines of IOC/IOA/GOI/SAI/ Government of Orissa shall be eligible for such financial assistance</li> </ol>   |
| <p>Para – 5</p> | <p>TERMS AND CONDITIONS</p> <ol style="list-style-type: none"> <li>(1) The concerned State Level Association/Individual should obtain relevant documents from the concerned National Federation with detail terms and conditions for participation of the Team/Individual in the International Tournament/competition e.g. Venue, Date, Duration, Nos. of participating countries, facilities in regards to accommodation etc. to be provided and the quantum of financial assistance to be extended by the International Federation.</li> <li>(2) The State Association/Individual must apply to the State Government alongwith all the relevant documents/papers atleast one month prior to the scheduled date of competitions indicating therein the quantum of financial assistance required in the enclosed proforma appended.</li> <li>(3) Financial assistance will be provided for purchase of kits/gears and pocket expenses as the responsibility of bearing the passage fare of the team/individual for participation in International events lies with the concerned Federations.</li> <li>(4) Sports persons selected for such participation if employed with State Government, Central Government, Private Firms, Public Sector Undertakings must furnish a certificate from the employer indicating whether his/her employer is providing any financial assistance or not and the permission to attend the International tournament.</li> </ol> |

(5) The quantum of financial assistance shall be determined as per the availability of funds in the budgetary provision. Preference will be given to applicants who fulfill the prescribed criteria of terms and conditions as fixed by the concerned International body within the stipulated period.

(6) Any addition or alternation in the existing scheme if required shall be done by the Administrative Department.
